### Goals of employment:

Involvement in plant biotechnology research with the POLS project No. UMO-2020/37/K/NZ7/02387, supervised by dr Benita Ortega Berlanga.

### Research area:

The conducted research will focus on: vector construction, plant cultivation and conducting of production of heterologous proteins using transient expression systems, purification and analyses of obtained proteins, analysis of animal samples after vaccination trials using obtained proteins.

### Qualifications:

- Familiarity with the current research and experimental techniques in plant biotechnology and molecular biology.
- Familiarity of basics of protein purification and analysis (ELISA, western-blot, etc.) preferred.

### Duties:
